

Mobility Zones Project - Community Leads Request for Applications Fregently Asked Questions

	Question	Asked Questions Answer
1	Will the Community Lead for Yuba and Sutter County receive the stipend for each county?	To be clear regarding payments, all payments from Civic Thread to Community Leads will not be stipends but rather traditional payments to the Community Leads via a contractual agreement with Civic Thread. If a Community Lead applies and is awarded for both Yuba and Sutter County (or any other combination of counties) then they would receive an award amount commensurate with the number of counties represented.
2	For the period of performance for our applications, can we apply for work starting in 2025?	The contract period will begin in 2025. We anticipate that the contracting process will be complete around January 2025 and work will begin then.
3	Will the lead(s) for Yuba and Sutter each receive \$70,000?	Applicants may request between \$70,000 - \$80,000 for each county represented.
4	Will the project continue through June 2027?	The Mobility Zones Project ends in the Fall of 2026. The estimated contract period for Community Leads is January 2025-June 2026, approximately 1.5 years. While the project ends September 2026, we only anticipate needing the Community Leads through June 2026. Timelines may shift.
5	Do applicants need to submit two separate applications for each county are they are applyingn for?	No. You will indicate in the application which counties you intend to represent and the total budget you are requesting.
6	If an organization applies for two counties, is it possible to be awarded one but not the other?	Yes, this is possible.
7	When is the application due?	September 22, 2024 at 11:59 PM PST
8	Is there a word document of the application? 9	Do you know how many orgaizations you plan to fund awards to?	We plan to fund no more than 6 organizations as Community Leads. However, we are open to awarding less than 6 if there are organizations that can sufficiently cover more than one county. We encourage and will accept project teams comprised of multiple organizations, but will only contract with one lead organization. Additional organizations on a project team would need to be brought on via subcontract or Memorandum of Understanding (MOU).

10	How can we know if another entity is applying within our county so we may share and negotiate with them?	Organizations that attended the RFA information session include: The Camptonville Community Partnership, California Health Collaborative, The Ring of Democracy, Sacramento Breathe, Beats Lyrics Leaders, Aura Planning, Jakara Movement, ACCE Institute, Inspirame, County of Yuba, and Yuba Sutter Arts
